SUBMISSION DEADLINE: January 15, 2021

- Photographers of all abilities are welcome to submit one (1) photograph.
- Photographs may be taken with any equipment at any skill level. Mobile phone snapshots are equally as welcome as photos taken with high-end equipment.
- Photograph needs to be high-quality in jpg, png, or tif form.
- Submissions must be submitted by 5 p.m. on January 15, 2021 and e-mailed to: amanda@krpa.org.
- Entries must include photographer's credit, location of the photo submission, and a short description (less than 30 words.)
- Entries must also include the KRPA Photo Contest agreement form (included in next page), scanned and/or digitally filled out and attached with the submitted photo.
- For this specific contest, photos must be submitted in color.
- Photos will be voted on via Facebook from January 20-31, 2021 . The photo with the most combined likes and shares by the end of the contest on January 31st will be the winner.
- The winning photograph will be used on the cover of the 2021 KRPA Today magazine, edition 2. This magazine will be printed and distributed to all KRPA members.
- Remaining submissions may be included in future KRPA or park and recreation promos or on the KRPA website.
